The correct dates are as follows-

- The second round will begin Monday, July 22, 2024. Residents and nonresidents are eligible.
- The third round will begin Monday, August 12. The sale of Deer Management Assistance Program (DMAP) permits also will begin on this date.
- The fourth round beginning Monday, August 26, 2024, a hunter can buy additional licenses until reaching their personal limit of six.
- The Elk Drawing will take place July 27th. The last day to apply is July 14th.

In addition, the PGC will be present at the Hookstown and Big Knob Fairs again this year.
